1. What every package includes

A non-exclusive, non-transferable licence to use all 36 Whispers of Wonder ebooks in PDF and EPUB. Ownership and copyright remain with Kokoshungsan Ltd and the author.

2. Choose the scope shown on your PayPal order

Individual Educator Licence

For one named teacher, librarian, educator or household.

- Use for personal reading, one educator's teaching, or within one household.
- Read aloud, display, and print reasonable copies for that named user's own learners or household.
- Do not share the source files with other staff, educators, schools, libraries or organisations.

School or Library Licence

For one named school, school library or public library at one location.

- Authorised staff at that location may use the ebooks for teaching, reading activities and on-site display.
- Files may be stored on a secure internal system accessible only to authorised staff or eligible patrons of that location.
- Library lending must use a controlled system that prevents public file sharing and unrestricted copying.

Five-Location Group Licence

For up to five named schools or library locations within one purchasing organisation.

- Includes the School or Library rights above at each named location.
- Access is limited to authorised staff and eligible users at those locations.
- Additional locations require a separate or tailored licence.

3. Restrictions applying to every package

You must not:

- resell, sublicense, rent or commercially redistribute the ebooks or substantially similar copies;
- upload the files to a public website, public drive, social network, file-sharing service or unrestricted learning platform;
- remove copyright, publisher or authorship notices;
- share files beyond the people and locations permitted by the purchased package; or
- use the artwork or text to create products for sale without separate written permission.

4. Digital delivery and cancellation

The collection is supplied as downloadable digital content; no physical product is shipped. By selecting immediate supply at checkout, a consumer asks for access to begin without waiting for the usual cancellation period and acknowledges that the right to cancel may be lost once downloading begins. This does not limit statutory rights or remedies for digital content that is faulty, misdescribed or not supplied with reasonable care.

5. Keeping and replacing the files

Keep your PayPal receipt and make a secure backup after downloading. If a download fails, contact Kokoshungsan Ltd with the PayPal order ID. Replacement access may be provided after the order is verified.

6. Termination

The licence continues indefinitely unless its terms are materially breached. If the licence ends because of a breach, all shared and stored copies outside any legally required archive must be deleted.
